SINCE OUR INCEPTION IN 2020, WE HAVE TOUCHED NEARLY 30,000 INDIVIDUALS IN NEED, RANGING FROM PHONE ADVICE, REFERRALS, TO ACTUAL LEGAL ASSISTANCE ALL THE WAY THROUGH AN APPEAL PROCESS FOR THEIR EVICTION. THE MAJORITY OF OUR CLIENTS ARE SINGLE MOTHERS OF COLOR. IN 2023-2024, 4,256 INDIVIDUAL CLIENTS WERE SERVED THROUGH DEAC'S ENDEAVORS. OF THOSE 4,256: 26 WERE ASIAN/PACIFIC ISLANDER (0.60%); 2,835 WERE BLACK/AFRICAN AMERICAN (66.60%); 570 WERE HISPANIC (13.4%); 140 WERE TWO OR MORE RACES (3.30%); 9 WERE NATIVE AMERICAN (0.20%); 421 WERE WHITE (9.90%); AND 255 WERE UNKNOWN/DECLINED TO ANSWER (6%). OF THOSE 4,256, 66.8% WERE FEMALE, 32% WERE MALE, 1% DECLINED TO STATE, AND 0.2% WERE NON-BINARY/TRANSGENDER. (CONTINUED ON SCHEDULE O)
